### 6. School Safety

Chip Watts

- a. Initial Safe Walking Route is due on October 31st
  - i. Dr. Watts asked that Brooke share Safe Walking Route with members prior to our next meeting
  - ii. Kathryn asked if we can change who qualifies for a bus. Example she gave: If I live 1.75 miles away but it takes 2.3 miles to walk to a safe cross walk, could this be considered to qualify for a bus?
- b. School Safety Plan is due December 19th
  - i. [Review these areas](#) that can be addressed on our School Safety Plan
  - ii. Admin is aware that pick up and drop off is difficult.
  - iii. In the south lot, parents picking up are backing in at an angle and it is causing problems for others to backup and or/or exit safely
  - iv. Another issue is the scooters at the school - multiple students on one scooter with no helmets, the SW corner students are parking scooters by the doors - this is a safety concern if we need to exit the school in an emergency. We also don't have enough parking spots for scooters.
  - v. Dr. Watts is working with the city regarding scooters.
  - vi. Dr. Watts reported that students are required to walk bikes and scooters on the property.

- d. We are no longer allowed to keep magnets to keep doors unlocked. Teachers can keep doors open and locked (all the way open and not propped) or closed and locked. Teachers are trying to figure how to do this and limit distractions
- e. Teachers will be receiving a panic button that will be on their badge - you have to continually push it and it won't go off if just bumped.
- f. Exterior facing windows of the school will be receiving a bullet resistant film.
