3. TSSP and Land Trust Chip Watts
 - a. Dr. Watts: teachers have been utilizing given data days to review data and work on other school goals and action plans. Common formative assessments were a focus of data days for quarter 1. Quarter 2's focus will be on teacher observations allowing teachers to continue to review best teaching practices and continued growth.
 - b. Expenditures are on goal for this time of year.
 - c. The ELA portion of our TSSP goal was approved by the district - increasing achievement level goal from 50% to 60%
4. Review ELA Scores Chip Watts

- a. RISE data was reviewed. Regarding ELA scores, a downward trend for achievement data for our school was discussed, and how that follows a similar downward trend from the state.
- b. It was noted that RISE testing is one measure of student achievement. It was asked what our school uses RISE data for. Dr. Watts described that students who score lower are identified and given opportunities for interventions and extra academic classes.
- c. MAP scores is another measure of student achievement that can be looked at. Ms. Smith asked if it was possible to see our scores MAP test and Dr. Watts stated that MAP scores can be shown at our next SCC meeting.
- d. Testing procedures for RISE testing was discussed - including how scores are examined by the state, used by the state/district, and opt-out percentages of Draper Park and other Utah schools. Different views and preferences of students taking RISE was also discussed.
